Emergency Action Planning - Are You Ready?

An emergency action plan (EAP) is a written document required by particular OSHA standards. The purpose of an EAP is to facilitate and organize employer and employee actions during workplace emergencies. Well-developed emergency plans and proper training will result in fewer and less severe employee injuries as well as less structural damage to the facility during emergencies. At minimum, the plan must include, but is not limited to, the following elements:

- Means of reporting fires and other emergencies
- Evacuation procedures and emergency escape route assignments
- Procedures for employees who remain to operate critical plant operations before they evacuate
- Accounting for all employees after an emergency evacuation has been completed
- Rescue and medical duties for employees performing them
- Names and job titles of persons who can be contacted

Sexual Harassment and Abusive Conduct Prevention Training

California law requires that employers with 50+ employees provide at least two hours of classroom or other effective interactive training and education regarding sexual harassment to all supervisory employees at least once every two years. New supervisory employees must receive the required training within six months of assuming the supervisory position. This two-hour California Manager Harassment Course is designed to meet these requirements, including coverage of the content guidelines as set forth in AB 1825, SB 292 and AB 2053.

California managers will review their responsibilities for preventing unwelcome and harassing behavior from occurring in their work groups and will receive guidance about the appropriate responses and measures to take if such behavior does occur.
