COVID-19 PREVENTION PLAN UPDATE (1.5 HOURS)

On June 17th CalOSHA made major changes to the COVID prevention program originally passed in November 2020. This seminar discusses CalOSHA's CCR Title 8 3205 CPP Standard, guiding management in making appropriate changes to their current programs.

TIPS (TRAINING FOR INTERVENTION PROCEDURES) (2 HOURS)

An essential training for anyone selling or serving alcohol, designed to prevent intoxication, drunk driving and underage drinking. By July 2022 this training will be required for all alcohol servers and managers at on-premises consumption establishments.

MUSCULOSKELETAL INJURY PREVENTION PROGRAM (1.5 HOURS) Aimed at owners/managers/supervisors/HR directors to help them understand the MIPP requirements and how to set up and/or refine their MIPP programs.

FIRST AID/CPR (2 HOURS) This course is certified through The American Red Cross for First Aid/CPR and participants will receive a provisional certification card for adult patients valid for one year from the American Red Cross.

BLOODBORNE PATHOGEN AWARENESS (1 HOUR)

The OSHA Bloodborne Pathogen standard requires employers to provide an annual awareness training to employees who are exposed to blood or other potentially infectious materials (OPIM). This training is designed for housekeeping and their management from a compliance perspective.

HAZCOM TRAINING (1 HOUR) Designed to protect employees from hazardous chemicals used or stored in the workplace. This level of training is an awareness training for applicable employees.

ANTI-HARASSMENT & ABUSIVE CONDUCT PREVENTION TRAINING FOR MANAGERS AND SUPERVISORS (2 HOURS) All employers with 5 or more employees must provide this training once every two years to all management positions.
